1. Rules:

This Series will be governed by the 2009-2012 Racing Rules of Sailing, the Class Rules of WF PHRF and by the current PGSC Sailing Instructions. (Available on web site, www.pgscweb.com)

2. Eligibility:

This event is open to all boats with current or pending WF PHRF Rating Certificates. Skipper and/or registrant must be a full member in good standing of PGSC or its respective area Yacht, Sail or Boat Club. Racing fleets for this event may include - Spinnaker, Non-Spinnaker, Cruising, and Multi-Hull. Classes may be sub-divided or combined as appropriate at the sole discretion of the Fleet Captain-Racing.

The boat's current (Exp. June 2010) WF PHRF rating certificate must accompany this registration form.

I do not have a WF PHRF rating and request the Race Management Committee assign one, pending receipt of the actual rating. ____ (I understand that the assigned rating is for the first two races of this Series only and cannot be appealed.)

3. Scoring:

This Series will be scored Time-on-Distance using the low point system. Depending on the type of course used for any given race, WF PHRF Buoy or RLC ratings will be used for scoring. **Boats registering after 9/26/2010 will not be scored in the series totals and will not be eligible for awards.**

Competitors participate in this event entirely at their own risk. See Rule 4, Decision to Race.

In consideration of your accepting my entry into the Sailing Program, I agree to be bound by the Racing Rules of Sailing, and standard Sailing Instructions which I will read and understand. My boat will be outfitted, equipped and handled in accordance with those instructions, and she shall be properly manned. I waive for myself, my executors and administrators, heir(s) and assigns, any and all claims as may accrue to me or them against the Punta Gorda Sailing Club, its officers, directors, employees and agents, and any one or more of them arising out of my participation in this event(s) or arising from any related activities.
